We conducted our review of the Statement in accordance with the Standard on Review Engagement (SRE) 2410, 'Review of Interim Financial Information Performed by the Independent Auditor of the Entity' issued by the Institute of Chartered Accountants of India (ICAI). A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. The Board of Directors, through a resolution dated December 16, 2024, has allotted 28,57,142 equity shares of face value of Rs 10/- each at a premium of Rs. 130/- per share aggregating to Rs. 4,000.00 Lakhs.
- 5. The Company has only one operating segment i.e., is engaged in manufacturing and selling of glass lined reactors, receivers and storage tanks and Company is specialized in providing the turnkey solutions for the pharmaceutical industry sector. Hence, the same becomes the reportable segment for the Company. Accordingly, disclosure of segment information as prescribed in the Indian Accounting Standard 108 "Operating segments" is not applicable.

The figures for the quarter ended December 31, 2024 are the balancing figures between the unaudited figures for the nine months ended December 31, 2024 and the audited figures for the half year ended September 30, 2024. The comparative financial information reported in the statement pertaining to corresponding quarter ended September 30, 2024, and quarter ended and nine months period ended December 31, 2023, have been prepared solely based on the information compiled by the management and has been approved by the Company's Board of Directors. Such information has not been subject to review by the statutory auditor.
