In terms of Section 108 read with Rule 20 of the Companies (Management and Administration) Rules, and Regulation 30 read with Para A of Part A of Schedule III and Reg. 44 of SEBI (LODR), Regulations 2015, **Promax Power Limited** provided remote e-voting facility and voting through ballot papers during the AGM to the Members vide notice dated 06<sup>th</sup> September, 2024 of the 07<sup>th</sup> AGM. To, The Chairman, Promax Power Limited First Floor, SCO 69, Sector 38C, Chandigarh – 160036

Subject: 07th Annual General Meeting (hereinafter referred to as "AGM") of the members of Promax Power Limited (CIN: L74999CH2017PLC041692) (hereinafter referred to as the "Company") held on Monday, September 30, 2024 at 11:00 A.M.

Dear Sir,

- I, Prachi A. Prajapati, Practicing Company Secretary (Membership No.: F13079, COP: 23015), appointed as Scrutinizer by the Board of Directors of Promax Power Limited (the Company) for the purpose of Scrutinizing the remote e-voting and poll process at the AGM of the Members held on 30<sup>th</sup> September, 2024 at 11:00 A.M. at the registered office of the Company situated at First Floor, SCO 69, Sector 38C, Chandigarh 160036 pursuant to the provisions of Section 108 & 109 of the Companies Act, 2013 (the "Act") read with Rule 20 & 21 of the Companies (Management & Administration) Rules, 2014, and pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 including any statutory modification or re-enactment thereof for the time being in force, in respect of the resolution proposed at the AGM. I hereby submit my report as follows:
  - a) The members whose names appeared in the Register of members/List of Beneficiaries as on the "Cut off" date, i.e. Monday, 23rd September, 2024 were entitled to vote through remote e-voting as well as voting at the venue;
  - b) The Company has provided remote e-voting facility for the AGM offered by NSDL for casting votes electronically by the members of the Company.
  - c) In terms of the Notice issued for AGM, remote e-voting was open for three days from Friday, September 27, 2024 at 09:00 A.M. (IST) to Sunday, September 29, 2024 at 05:00 P.M. (IST). 1 (One) member had utilised the facility to cast the vote through remote evoting.
  - d) The facility for voting through ballot papers was made available at the venue of the AGM for members, who attended the AGM and had not voted on the resolution through remote e-voting, to cast their vote at the AGM. 9 (nine) members had utilised the facility to cast the vote at the AGM.





- e) After the conclusion of remote e-voting period, the report on voting done through remote e-voting on the NSDL e-voting platform were unblocked and downloaded in the presence of two witnesses who are not in the employment of the Company;
- f) The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and the Rules made thereunder; (ii) the MCA circulars; and (iii) the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 ("LODR") relating to remote e-voting and voting through ballot papers on the resolutions contained in the Notice calling the AGM. The management of the Company is responsible for ensuring a secured framework and robustness of the electronic voting systems.
- g) My responsibility as a scrutinizer for remote e-voting and voting though ballot papers process is restricted to making a Scrutinizer's report of the votes cast "in favour" or "against" by the members in respect of the resolutions contained in the Notice. My report is based on verification of data and reports generated from the voting system provided by National Securities Depository Limited ("NSDL"), the Agency authorized under the Rules and engaged by the Company to provide evoting facility and papers/ documents furnished to me electronically till the time fixed for closing of the e-voting process referred hereinabove.

# I hereby submit the scrutinizer's report on the results of voting by remote e-voting and as well as voting through ballot papers at the AGM as under:

- 1. After the time fixed for closing of the poll by the Chairman, one (1) ballot box was kept for polling was locked with due identification marks placed.
- 2. The locked ballot box was subsequently opened in our presence with two witnesses being Ms. Maitri Y. Thakkar and Mr. Sagar Vidhani. The result of the Poll is as under:
  - 8 (Eight) Member had cast their votes through ballot papers at the AGM.
  - 1 (One) Member had cast their votes through remote e voting.
