Dear Sir,

I, Shilpesh Dalal, Practicing Company Secretary, 219, D.M. Tower, 21/1, Dr. R.S. Bhandari Marg, Janjeerwala Square Indore, was appointed as Scrutinizer to scrutinize the remote e-voting and e-voting during the 32ndAnnual General Meeting ('AGM') of Vippy Spinpro Limited ('the Company'), carried out pursuant to Section 108 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014, as amended, and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, on the Ordinary Business (Item Nos. 1&2) and Special Business (Item No. 3, 4 & 5) set forth in the Notice of the 32<sup>nd</sup>AGM of the Company held on Thursday, September 19, 2024 at 11:30 A.M. (IST) through Video Conferencing/ Other Audio Visual Means, in a fair and transparent manner.

As per Ministry of Corporate Affairs General Circular No. 14/2020 dated April 8, 2020, Circular No. 17/2020 dated April 13, 2020, Circular No. 20/2020 dated May 5, 2020, General Circular No. 02/2021 dated 13<sup>th</sup> January, 2021, Circular No. 02/2022 dated 05<sup>th</sup> May, 2022followed by MCA Circular dated 28" December, 2022(hereinafter collectively called as MCA Circulars), read along with SEBI Circular dated 5<sup>th</sup> January, 2023 the Company held the 32<sup>nd</sup> AGM through VC/OAVC, without the physical presence of Members at a Common venue.

I submit my report as under:

In compliance with MCA Circulars and SEBI Circular SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated 12th May, 2020,13<sup>th</sup> May,2022, followed by MCA Circular dated 28" December, 2022and 5<sup>th</sup> Jan, 2023, Notice of the 32<sup>nd</sup> AGM along with Annual Report 2023-24 has been sent by the Company only through electronic mode to those Members whose e-mail address were registered with the Depository/the Company's Registrar & Transfer Agent –National Securities Depository Limited. The Company had completed their dispatch on August 09, 2024.

- 2. The cut-off date for e-voting was Thursday, September 12, 2024. As on cut-off date, there were 7961Share holders in the company. Only those Members, whose names appeared in the Register of Members/List of Beneficial Owners as on the Cut-off date were entitled to vote (through remote e-voting &e-voting during the AGM) on the Ordinary Business (Item Nos. 1&2) and Special Business (Item No. 3, 4 & 5) set forth in the Notice of 32ndAGM and their voting rights were in proportion to their share in the paid-up equity share capital of the Company as on the Cut-off date.
- 3. The total paid-up equity share capital of the Company as on the Cut-off date was Rs. 5,87,00,000/- divided into 58,70,000 equity shares of Rs. 10each, fully paid-up.

The Company had engaged the services of National Securities Depository Limitedas the Agency to provide facility for remote e-voting and e-voting during the AGM.

- 4. The remote e-voting commenced at09:00 A.M. (1ST) on Monday, September 16, 2024 and ended at 5:00 P.M. (IST) on Wednesday, September 18<sup>th</sup>, 2024.
- 5. Members who were present in the 32ndAGM through VC/OAVM and have not casted their vote through remote e-voting were allowed to vote through e-voting during the AGM.
- 6. After the conclusion of e-voting in the 32ndAGM, the votes cast through remote e-voting and e-voting during the AGM were unblocked in the presence of Ms. Marvi Budhwani and Mr. Priyansh Gopwani.
- The requisite register has been maintained to record the assent or dissent received, mentioning the
  particulars of Name, Address, Folio No, DP ID, Client ID of the Members, No.of shares held by them,
  Nominal value of such shares.

55(Fifty Five) Members were present at the 32ndAGM through VC as per the Attendance Report generated through NSDL eVoting System and 65(Sixty Five)Share Holders participated in e-voting, holding total 38,14,759(Thirty Eight Lakh fourteen Thousand Seven Hundred and Fifty Nine) Shares.
