Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015 and SEBI Circular no. CIR/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, this is to inform you that RITES had received a Show cause notice from the Office of Deputy Commissioner of State Tax (SGST), Gurugram (East), Government of Haryana for an amount of Rs. 155,31,01,021/- and the same was intimated to the Stock Exchanges on 05.08.2024.

Subsequent to our replies, we have received a Demand order from Office of Excise and Taxation Officer, Gurugram(East), Government of Haryana on 03.02.2025 for Rs. 3,80,90,504/- as against the aforesaid SCN.
