And now, the sound of a woman's voice outside the home has been outlawed in Afghanistan, according to a released late last month that codifies all of the Taliban government's decrees restricting women's rights. The new law barring women's voices they are considered an intimate part of a woman that must be covered effectively ensures that women cannot leave the house without a male relative. A large majority of the prohibitions have been in place for much of the Taliban's three years in power, slowly squeezing Afghan women out of public life. But for many women across the country, the release of the document feels like a nail in the coffin for their dreams and aspirations. Some had clung to the hope that the authorities



might still reverse the most severe limitations, after Taliban officials suggested that high schools and universities would eventually reopen for women after they were shuttered. For many women, that hope is now dashed. "We are going back to the first reign of the Taliban, when women did not have the right to leave the house," said Musarat Faramarz, 23, a woman in Baghlan Province, in northern Afghanistan, referring to the movement's rule from 1996 to 2001. "I thought that the Taliban had changed, but we are experiencing the previous dark times again." 

If the sight of dozens of men accused of raping her, including her husband of many decades, upset Gisèle Pelicot, she did not let it show. She swept into a packed courtroom Thursday with steely poise, her face composed, her eyes dry beneath sunglasses. Her adult children trailed behind her. Then, she took the stand and told the court how the life she had built over five decades had quick-

ly unraveled one morning in late 2020, when the police summoned her to a station in southern France. There, they told her that the man she considered the love of her life had been drugging her for almost a decade and inviting strangers to come into their home and join him in raping her while she was comatose. Under French rules, Pelicot, 71, could have avoided letting the trial play out in the pub-lic eye and chosen to keep it behind closed doors. Instead, she decided it was important for all of France to hear her story and to place the shame on the



There are so many men on trial that the court had to build a second glass box in the courtroom for those in custody. They include firemen, soldiers, truck drivers, an IT expert. They range in age from 26 to 74. Many are in stable relationships and have children. Dominique Pelicot has pleaded guilty to all the charges against him, including aggravated rape and drugging. He is also accused of violating the pri-vacy of his wife, daughter and two daughters-in-law on suspicion of illegally recording, and at times distributing, intimate photos of them. If he is found guilty, he faces up to 20 years in prison. He hopes to use the trial to explain himself to his now ex-wife and estranged children, according to his lawyer, Béatrice Zavarro. Standing at a lectern before the row of judges in the courtroom, Gisèle Pelicot never showed much emotion. She referred to her former husband formally, as "Monsieur Pelicot."

Muhammad Yunus calls for resolving issues over **Teesta water-sharing treaty with India**

DHAKA (AGENCY)

Bangladesh's Chief Adviser Muhammad Yunus has said the interim government would pursue with India ways to resolve the differ-ences over the long-pending Teesta water sharing treaty, as delaying it for years serves no purpose for either nation. at his official residence in Dhaka, Yunus stated that the water-sharing issue between the two countries must be resolved according to international norms, emphasising that lower riparian countries like Bangladesh have specific rights that they seek to

uphold. "By sitting over this issue (water sharing), it is not serving any purpose. If I know how much water I will get, even if I am not happy and sign it, it would be better. This issue has to be resolved," he said. Replying to a query on whether the interim government would push for resolving the issues over the Teesta water-sharing treaty at the earliest, he said the new regime will pursue it. "Push is a big word; I am not saying it. We will pursue it. But we have to sit together and resolve it," he. India and Bangladesh were set to sign a deal on Teesta

GEORGIA (AGENCY) More than a year ago, tips about online posts threatening a school shooting led Georgia police to interview a 13-year-old boy, but inves-tigators didn't have enough evidence for an arrest. On Wednesday, that boy opened fire at his high school outside Atlanta and killed four people and wounded nine, officials said. The teen had been interviewed after the FBI received anonymous tips in May 2023 about online threats to commit an unspecified school shooting, the agency said in a statement. The FBI nar-

rowed the threats down and referred to the case to the sheriff's department in Jackson County, which is adjacent to Barrow County. The sheriff's office inter-viewed the then-13-yearold and his father, who said there were hunting guns in the house but the teen did not have unsupervised access to them. The teen also denied making any online threats. The sheriff's office alerted local schools for continued monitoring of the teen, but there was no probable cause for arrest or additional action, the FBI said. The teen has been charged.

Israeli airstrike hits Al-Aqsa Martyrs hospital in central Gaza killing four people

Hours after the first phase of a polio vaccination campaign wrapped up in central Gaza, an Israeli airstrike hit the courtyard of hospital there, underscoring the limited nature of the pauses in combat to allow health care workers to reach children. The strike outside Al-Aqsa Martyrs Hospital occurred overnight, shortly before World Health the Organisation said on

Thursday that the effort to vaccinate children had shifted to the southern part of the Gaza Strip, beginning the second phase of the campaign. Israel has agreed to brief, staggered pauses in its military offensive in Gaza to allow health officials to make a frantic drive to vaccinate hundreds of thousands of children and avert a deadly polio outbreak.
