Subject.: Deferment Intimation of Annual General Meeting for the financial year ended March 31, 2024.

The Company was required to hold its Annual General Meeting for the financial year ended March 31, 2024, latest by September 30, 2024.

The Company is presently not in a position to call and hold the said Annual General Meeting within the prescribed time of September 30, 2024, as it does not have a Board.

That further, it is in the process of seeking regulatory and other approvals for appointment of new board of directors. Kindly refer to our exchange intimation dated 23.09.2024 for more details.

That, therefore, the Company had sought extension of three months from the Registrar of Companies (ROC-Delhi) under Section 96(1) of the Companies Act, 2013. Which is pending before ROC-Delhi for the reasons as follows:-

That the Company , despite its best efforts could not electronically upload its extension application on Ministry of Corporate Affairs (MCA) V2 portal due to certain internal errors on MCA site. It had therefore-

- c) It had also escalated the matter and sought the kind intervention of Sh. Vivek, Deputy Director, E-Gov, Ministry of Corporate Affairs, New Delhi on 09.09.2024
- d) It had also through, the Institute of Company Secretaries of India (ICSI) raised the issued of internal errors in MCA- V2 portal and sought their help in taking up the issue with MCA for resolution. The request was sent on 23.09.2024.
