Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that Dalmia Cement (Bharat) Limited ('DCBL'), wholly owned subsidiary of the Company, has entered into Share Subscription and Shareholders agreement ('SSSHA') on October 1, 2024, to acquire 25.38% of equity share capital of Bijlee Kandasamy Private Limited, consisting of 33,00,000 equity shares aggregating to Rs.3,30,00,000/- (Rupees Three Crore Thirty Lacs only), in one or more tranches to source solar power as a captive consumer for a capacity upto 11.00 MW located in the State of Tamil Nadu.

The transaction is subject to customary conditions precedents and expected to be completed within 2 Months.
