- The special businesses as set out in the Postal Ballot Notice will be transacted through remote e-voting only.
- A person whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories/KFinTech as on the cut-off date, i.e., Friday, November 1, 2024 only shall be entitled to avail the facility of remote e-voting. Once the vote on the resolution is cast by the Member, he/she shall not be allowed to change it subsequently or cast the vote again.
- The remote e-voting period commences on **Friday, November 15, 2024 at 9:00 A.M. IST** and ends on **Saturday, December 14, 2024 at 5:00 P.M. IST**. During this period, Members holding shares as on cut-off date, may cast their vote electronically.
