But on the basis of written representation received from the management we have been informed that the situation is temporary in nature and in the near future they will carry on the business effectively. The above factors cast a significant uncertainty on the company's ability to continue as a going concern. Pending the resolution of the above uncertainties, the Company has prepared the aforesaid statement on a going concern basis.

Key Audit Matters
