mentioned resolution was sent by e-mail to all Members of the Company, whose names appeared in the Register of Members/ List of Beneficiaries as received from National Securities Depository Limited ("NSDL")/ Central Depository Services (India) Limited ("CDSL") as on Friday, October 25, 2024 ("cut-off date") and whose e-mail IDs were registered with the Company or its Registrar and Transfer Agent and/or their Depository Participants.

- 2. In compliance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI LODR Regulations") and pursuant to the provisions of Sections 108 and 110 of the Act read with the Rules framed thereunder and the MCA Circulars, the manner of voting on the resolution was restricted only to e-voting i.e., by casting votes electronically instead of submitting postal ballot form. Accordingly, the Postal Ballot Notice and instructions for e-voting were sent only through electronic mode and no hard copy of Postal Ballot Notice, Postal Ballot Form and pre-paid business reply envelope were sent to the Members. Accordingly, the communication of the assent or dissent of the Members took place through remote e-Voting.
- 3. The Company had availed the e-voting facility offered by National Securities Depositories Limited ("NSDL") for extending the facility of remote e-voting to the Members of the Company.
- The remote e-voting period commenced on Tuesday, October 29, 2024 at 09:00 A.M. (IST) and concluded on Wednesday, November 27, 2024 at 05:00 P.M. (IST).
- 5. We have monitored the process of remote e-voting through the scrutinizer's secured link provided by NSDL through its designated website.
- 6. On completion of e-voting, the votes cast through remote e-voting facility were unblocked by us in the presence of two witnesses who were not in the employment of the Company. We have downloaded the e-voting report from the website of NSDL in respect of Members, who voted through remote e-voting and votes were counted.
- We have scrutinized and reviewed the remote e-voting provided to Members and votes cast therein based on the data downloaded from the NSDL e-voting system.
- 8. As on cut-off date, there were 1,16,522 shareholders of the Company who were entitled to vote on the resolution proposed for the approval of Members of the Company through Postal Ballot by means of remote e-voting.

- 9. The management of the Company is responsible to ensure compliance with the requirements of (i) the Act and Rules made thereunder; (ii) MCA Circulars and (iii) the SEBI LODR Regulations, relating to Postal Ballot process through remote e-voting.
