Pursuant to Regulation 30 read along with Para-B, Part-A of Schedule III of the SEBI Listing Regulations, it is hereby informed that on Wednesday, January 1, 2025, at approximately 19:55 HRS, fire broke out at the Company's Plant, located at Plot No. 113/114, MIDC Dhatay, Near Police Station, Kolad-Roha Road, A.V. Roha A.V. P. O. - Dhatav, Taluka - Roha, Dist.-Raigad 402 116, India. The warehouse is used for storage of pigment in process goods used for final manufacturing. There have been no injuries or casualties.

The team at our Factory with support from the neighbouring industries, got the situation under control around 20:45 hrs.

The Company is currently investigating the root cause of the incident and assessing the extent of damage. We will provide an update on our findings in due course.

Additionally, we would like to inform you that the company has adequate insurance coverage. The claim process with the insurance company has been initiated, and we have requested a surveyor to assess the situation. The Company is committed to ensuring the highest safety standards.
