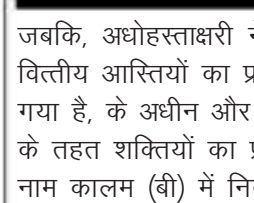

**शनिवार, 13 जुलाई, 2024 को आयोजित होने वाली असाधारण आम बैठक में दिनांक 21 जून, 2024 को जारी नोटिस और उसके साथ संलग्न व्याख्यात्मक विवरण का दूसरा सुद्धिपत्र**
