The meeting was held by Video Conferencing (VC) or any other audio- visual means (OAVM) in compliance with the applicable provisions of the Companies Act, 2013, General Circular Nos. 14/2020 dated April 8, 2020 and 17/2020 dated April 13, 2020, followed by General Circular Nos. 20/2020 dated May 5, 2020, and subsequent circulars issued in this regard, the latest being 9/2023 dated September 25, 2023 (collectively referred to as "MCA Circulars") and the Securities and Exchange Board of India (SEBI) vide its Circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 and Circular No. SEBI/HO/CFD/CMD2/CIR/P/2021/11 dated January 15, 2021 and subsequent circulars issued in this regard, the latest being Circular No. SEBI/HO/CFD/CFD-PoD-2/P/CIR/2023/167 dated October 07, 2023 (collectively referred to as "SEBI Circulars") has permitted to conduct the Annual General Meeting (AGM) of the Company through Video Conferencing (VC) / Other Audio-Visual Means (OAVM), without the physical presence of the Members at a common venue.

The meeting was attended by **82** members through VC/ OAVM until the conclusion of meeting.

All the above-named Directors participated in the Meeting through Video Conference. Mr. Sanjay Kumar Sanghi, Chairman & Managing Director of the Company and Mr. Ritesh Kumar Sanghi, Director and Mr. Bajranglal Agarwal, CFO, attended the Meeting from a common location at the registered office of the Company. Mr. Balasubramanyam Danturti - Independent Director attended the meeting from Thailand. Further all the Directors/ KMP provided the confirmation that the panelist is audible to them.

The Company Secretary informed the Members that the Company had provided its Members the facility to cast their vote electronically through the Central Depository Services (India) Limited (CDSL), system before the Meeting. She further informed that the remote e-voting facility was also made available during the AGM for the benefit of Members who were present during the Meeting and had not cast their votes earlier through remote e-voting.
