Dear Sir/Madam,

This is in reference application, dated 20th September 2024, submitted by **Raconteur Global Resources Ltd ("Company")** for seeking Reclassification of Promoter shareholders under the provisions Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI LODR'), wherein Regulation 31A(8)(c) states that

Principles governing disclosures and obligations Regulation 31(8)(c)

The following events shall deemed to be material events and shall be disclosed by the listed entity to the stock exchanges **as soon as reasonably possible and not later than twenty four hours from the occurrence of the event:**

(c) submission of application for re-classification of status as promoter/public by the listed entity to the stock exchanges;

It is observed that the Company has submitted the application with the Exchange on September 20, 2024. However, disclosure regarding the same has been submitted on 9th October 2024.

The aforesaid non-compliance on your part is viewed seriously. You are hereby advised to be careful in future, exercise due caution and initiate corrective steps to avoid recurrence of such lapses so as to ensure due compliance with the Exchange circulars/guidance/communications. Any aberrations in future will be viewed seriously and appropriate action would be initiated.
