**New Delhi, 13th Feb 2025:** Cosmo Ferrites Limited, a leading manufacturer and exporter of Soft Ferrites and an emerging player in wire wound magnetic components today declared its financial results for the quarter ended 31st December 2024.

Q3 FY25 EBITDA is higher backed by additional volumes and cost rationalization.

Following the company's request, the government launched an anti-dumping investigation into imports of soft ferrite cores from a neighboring country. The Directorate General of Trade Remedies (DGTR) published its final findings in a gazette notification dated December 23, 2024, recommending a 35% anti-dumping duty on CIF value of specific manganese-zinc ferrite cores originating from China. This duty will take effect once approved and notified by the Central Government. The company anticipates that this measure will lead to increased capacity utilization and improved margins.

**Commenting on Company's performance Mr. Ambrish Jaipuria, Chairman, Cosmo Ferrites Ltd.** "The company has successfully developed couple of new products tailored for higher end applications. The Company has also recently started supplying ferrite cores to ISRO and BHEL for strategic applications. Cosmo signed NDA with CSIR-CSIO to accelerate development for multidimensional applications of ferrite materials. The company is focusing on emerging trends of technological advancement including advanced materials for EV and solar applications. The Company is in process of enhancing automation to optimise cost and improve production efficiency which should yield results from FY26."
