Dear Sir/Madam,

We refer to our letter no. IDFCFIRSTBANK/SD/58/2024-25 dated May 16, 2024 intimating the stock exchanges about receipt of approval of the Reserve Bank of India ("RBI"), under Section 35B of the Banking Regulation Act, 1949, for the appointment of Mr. Pradeep Natarajan as the Whole-Time Director of the Bank stated therein.

In this regard, we wish to inform that consequent to RBI approval and basis the recommendation of Nomination and Remuneration Committee, the Board of Directors of the Bank at its meeting held on May 30, 2024, have approved the appointment of Mr. Pradeep Natarajan (DIN: 10499651) as the Whole-Time Director (Additional Director), designated as Executive Director of the Bank, with effect from June 01, 2024 for a period of three (3) years. His appointment shall be subject to approval of the shareholders of the Bank. He shall also be designated as Key Managerial Personnel during his tenure as the Whole-Time Director of the Bank.

Relevant details including Mr. Natarajan's brief profile as required in terms of Regulation 30 of the SEBI Listing Regulations, read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 is enclosed as **Annexure 1**.

In accordance with circular nos. LIST/COMP/14/2018-19 and NSE/CML/2018/02, both dated June 20, 2018, issued by BSE Limited and National Stock Exchange of India Limited, respectively, Mr. Natarajan is not debarred/disqualified from holding office of director by virtue of any Order of Securities and Exchange Board of India or any other such authority.

In terms of the applicable provisions of the SEBI Listing Regulations and consequent to the aforesaid appointment of Mr. Pradeep Natarajan as the Whole-Time Director of the Bank, all the employees who are directly reporting to him shall be construed as the Senior Management Personnel of the Bank ("SMP"), with effect from the June 01, 2024. In this regard, the list of SMPs are enclosed as **Annexure 2**.
