Furthermore, the Parent Company has entered into a settlement agreement with the said distributor, executed to a reparent in accordance with court proceedings. The Parent Company has created rights and Interests over valuable immorporeries located in Gruzgarma and Delht. The residual value of these properties is expected to adequately cover the outsite.
