**A) “Annual General Meeting” of the members of the Company:**

- 1) This is to inform that the 35th Annual General Meeting (“AGM”) of the members of the Company will be held on Wednesday, August 28, 2024 at 11.00 a.m. (IST) through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”), in accordance with the relevant circulars issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India.
- 2) In compliance with the relevant circulars, the Annual Report for the financial year 2023-24, comprising the Notice of the AGM and the standalone and consolidated financial statements for the financial year 2023-24, along with Board's Report, Auditors' Report and other documents required to be attached thereto, duly sent through email to every member of the Company whose email address are registered with the Company / Depository Participant(s).
- 3) The details such as manner of (i) registering / updating mobile no. and email addresses, (ii) casting vote through e-voting and (iii) attending the AGM through VC / OAVM has been set out in the Notice of the AGM.
- 4) The Company has fixed Wednesday, August 21, 2024 as the “Cut-off Date” for the purpose of determining the members eligible to vote on the resolutions set out in the Notice of the AGM or to attend the AGM.

**B) “Record Date” and “Dividend payment”**

- 5) The Company has fixed Wednesday, August 21, 2024 as the “Record Date” for the purpose of determining the members eligible to receive dividend for the financial year 2023-24.
- 6) The dividend, if declared at the AGM, will be paid on and from September 3, 2024 within the statutory time limit of 30 days of the AGM.

**C) “Book closure”**

- 7) The Register of Members and Share Transfer Books of the Company will remain closed from Thursday, August 22, 2024 to Wednesday, August 28, 2024 (both days inclusive) for declaration of dividend of Re. 1/- per Equity Share of Rs. 10/- each, if approved at the AGM.

During the period shareholders of the Company holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. 21<sup>st</sup> August, 2024, may cast their vote electronically.
