

कालाका समाक्राक स्थिक (स्थान কলেজের অধ্যক্ষকে শুমাক দেওয়ার অভিযোগ উঠল কলেজেরই দুই অশিক্ষক কর্মীর বিরুদ্ধে। ঘটনাটি ঘটেছে বাসন্তী থানার কুলতলি সুকান্ত কলেজে। ইতিমধ্যেই বাসন্তী থানায় অভিযোগ জানিয়েছেন কলেজের অধ্যক্ষ। ঘটনার তদন্ত শুরু করেছে পুলিশ। অভিযুক্ত ওই দুই অশিক্ষক কর্মীর নাম ফিরোজ খান ও পুহ আশক্ষক কমার নামা ফরোজ খান ও সইফুদ্দিন খান। ফিরোজ গুই কলেজের রক্ষী। সইফুদ্দিন পিওন। উল্লেখ্য, কলেজে অধ্যক্ষ হিসেবে যোগদানের পর থেকেই তাঁর সঙ্গে যথেষ্ট দুর্বাবহার করেন গুই দু'জন। অভিযোগ, গত দেড় বছর ধরে ওই দুই অশিক্ষক কর্মী অধ্যক্ষের সঙ্গে বর্ববেহার করছেন বলে জানিয়েছেন তিনি। দুর্ব্যবহার করাছেন বালে জানিয়েছেন তিনা । এ বিষয়ে অধ্যক্ষ প্রশাচরণ হোতা বালেন, কলেজে যোগদানের পর থেকে বিভিন্ন বিষয়ে ওই দু 'ভান অপমান করার চেষ্টা করে থাকেন বারবার তাঁদের বুঝিয়ে বলার পরও কোনও কাজ হন্তনি। শুক্রবার তাঁরা কলেজে দেরিতে আসেন। এবং তা নিয়ে বলতে গেলেই অগ্লীল ভাষায় আক্রমণ করা হয়। যদিও অভিযুক্তরা অধ্যক্ষের সঙ্গে দুর্ব্যবহারের কথা অধীকার করেছেন।
