This is with reference to the 1st Interim Dividend of Rs.25/- per equity share of Rs.5/- each fully paid up (500%) for the Financial Year 2024-25, declared by the Company on 12th February, 2025.

2. In terms of the provisions of the Income-tax Act, 1961, as amended by the Finance Act, 2020, dividend paid or distributed by a Company on or after 1st April, 2020 shall be taxable in the hands of the shareholders. The Company shall therefore be required to deduct tax at source at the time of payment of dividend.

3. Any declaration towards the same shall be submitted to the Company at investors@hal-india.co.in on or before 18th February, 2025.
