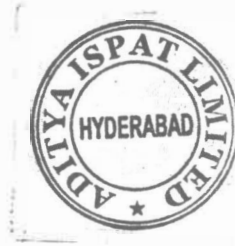


We further confirm that as on March 31, 2024 NIL number of shares of the company are encumbered or pledged by us.
