Sub: Consolidated Scrutinizer's Report on e-voting conducted pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 and Secretarial Standards on General Meetings for the 11<sup>th</sup> Annual General Meeting of Tierra Agrotech Limited held on Wednesday 14<sup>th</sup> August, 2024, at 10.00 A.M. (IST) through video conferencing ('VC') / other audio visual means ('OAVM').

With reference to the above subject I, N. Vanitha, Practising Company Secretaries, state that I was appointed as the Scrutinizer by the Board of Directors of Tierra Agrotech Limited pursuant to Section 108 of the Companies Act, 2013 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote e-voting process held during the period August 11, 2024 to August 13, 2024 and e-voting done at the 11<sup>th</sup> Annual General Meeting ("AGM"), conducted through video conference ('VC') / other audio visual means ('OAVM') mode, held on Wednesday, August 14, 2024 at 10:00 A.M. in a fair and transparent manner, for ascertaining the requisite majority and for giving my report in connection with the items of business as provided in the notice dated 15th July, 2024. In this regard I report as under:

- The notice dated July 15, 2024, convening the AGM, as confirmed by the Company was sent to the shareholders in respect of the below mentioned resolutions passed at the AGM of the Company through electronic mode to those Members whose e-mail addresses are registered with the Company/Depositories, unless any Member has requested for a physical copy of the same. The Company had availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting by the Shareholders of the Company.
- 2. The Company has availed the e-voting facility offered by Central Depository Services (India) Limited (CDSL) for conducting remote e-voting by the Shareholders of the Company. The voting period for remote e-voting commenced on August 11, 2024 at 09:00 A.M. and ends on August 13, 2024 at 05:00 P.M. and the CDSL e-voting platform was disabled thereafter. The shareholders whose names appeared in the Register of Members / List of Beneficial Owners as on Wednesday, 07<sup>th</sup> day of August, 2024 (i.e., cut off date) were allowed to participate and vote electronically on all the items of business during the aforesaid period of e-voting.
- 3. At the 11<sup>th</sup> AGM of the Company held on Wednesday, August 14, 2024, at 10:00 A.M. the Company had also provided e-voting facility to such shareholders present at the AGM conducted through VC



/ OAVM, and had not participated in the e-voting facility provided during August 11, 2024 (9:00 hrs) to August 13, 2024 (17:00 hrs) to cast their votes.

- 4. After the closure of E-voting during the AGM, the voting done at the AGM and the votes cast through remote e-voting facility prior to the AGM were unblocked and reconciled with the records maintained by the Company / Registrar and Share Transfer Agents of the Company and a combined report has been generated based on the data downloaded from the CDSL e-voting system.
- 5. I have scrutinized votes cast by way of remote e-voting and e-voting during the AGM, based on the data downloaded from the CDSL e-voting system.
- 6. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to voting through electronic means on the resolutions contained in the notice to the 11<sup>th</sup> Annual General Meeting (AGM) of the Equity Shareholders of the Company.
