

Ahmedabad, An elderly resident of Juhapura in Ahmedabad has lodged a complaint against his son, alleging verbal abuse and threats of physical harm.

Ismail Ali Akbar Ali Shaikh, 73, residing of 152 Sankalit Nagar, Juhapura, reported that on Thursday evening, his elder son Munwar (40) demanded money from his mother Akhtarunisha, who was managing their shop situated outside their residence. When she refused, Munwar allegedly became aggressive, used abusive

mattress.

Hearing the commotion, Ismail intervened, only to face similar verbal abuse. The situation escalated when Munwar reportedly retrieved a sword from the house, threatening to break his father's limbs if his monetary demands were not met. Concerned for their safety, Ismail contacted the police,

who responded promptly to the scene. In his complaint, Ismail detailed the incident, expressing his distress over his son's actions. He stated that Munwar, along with his wife Shahrbanu and their three children, reside on the upper floor of their family home, while Ismail lives on the ground floor with his wife, younger son Asif, and his family. The Vejalpur police have registered the complaint and initiated an investigation into the allegations. Authorities are examining the family dvnamics and any underlying issues that may have contributed to confrontation.

The Gandhinagar court has given an important verdict in

the murder case of 25-yearold Devansh Romi Bhatia, who worked as a receptionist at the prestigious five-star Hotel Leela in Gandhinagar. The court has sentenced two accused to life imprisonment.

On 8 October 2021, Devansh's bloody body was found near a tea kettle near a garden in Sector-27. The accused attacked him with a sharp weapon and robbed him of Rs. 1050 in cash, important documents and his mobile phone hands-free from his

In 2021, a body was found near the corner of the garden

of Se-27. Devansh Romi Prannath Bhatia, 25, originally from Vadodara, was working at the five-star Hotel Leela in Gandhinagar. He was working at the reception counter in the hotel and was living on rent on the upper floor of Ramilaben Patel's house in Sector-27. On the morning of October 8, 2021, the kettle owner informed the police that his body was lying in a bloodsoaked condition near the tea kettle near the corner of the garden of Sector-27. Following which a case of murder with robbery was registered at the Sector-21 police station.

Bhatia's mobile location was Raipur.

In this case, the police checked the location of Devansh's mobile and found that his mobile was switched off from Raipur, Ahmedabad. But since his previous location was in Vastrapur, he was tracked from there and got

down at Geeta Mandir in an and it was revealed that three Ola bike. Based on this, the cameras of Gandhinagar Pathikashram ST depot were checked. In which Devansh was seen coming out of Pathikashram. After that, all the CCTV footage of Gh Road, Sector-22 and Sector-23 were checked. However, Devansh was not seen walking. Therefore, the local crime branch changed the direction of the investigation of the entire crime and identified the number plates of all the vehicles that passed through Gh-5 and questioned them all.

Plot No. 501/1, Sector-13/A), Ghanshyam alias Kalu Naranbhai Kanani (Res. Plot No. 406/1, Sector-13/A), along with a 17-year-old teenager who was in conflict with the law. And filed a charge sheet in the court with the necessary supporting

evidence. The court imposed life imprisonment and fine.

The case went before Gandhinagar Principal District and Sessions Court Judge H. I. Bhatt, and government lawyer Jignesh Joshi made strong arguments.
