This is with reference to the cited matter in which the undersigned was appointed as Liquidator of Leel Electricals Limited ("Company" or "Corporate Debtor") by the Hon'ble National Company Law Tribunal, Principal Bench, Allahabad vide order dated 06.12.2021 under the provisions of Insolvency and Bankruptcy Code, 2016.

In accordance with the provisions of Insolvency and Bankruptcy Code, 2016 ("IBC") read with IBBI (Liquidation Process) Regulations 2016, the Undersigned, as Liquidator of Leel Electricals Limited, has successfully sold the Company as going concern through an e- auction held on 10.04.2023 to Krishna Ventures Limited ("Successful Bidder") and the consideration in this regard has been also received. The aforementioned sale as going concern was approved by the Hon'ble NCLT vide order dated 21.03.2024. Further a sale certificate dated 12.06.2024 confirming the sale of the Company to the successful bidder has been issued by the Liquidator.
