- 1. The Company has given the Ballot Paper to the Members who were present at the AGM held on Friday, 27th September, 2024 at 11.00 A.M at the Registered Office of the Company.
- 2. Particulars of all the Ballot Papers received from the Members and the votes cast by electronic mode have been entered in register maintained for the purpose.
- 3. The Ballot Papers were kept under our safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such Ballot Papers.
- 4. The ballot box was opened in our presence.
- The ballot forms were duly opened in our presence and scrutinized and the shareholding was matched / confirmed with the Register of Members of the Company as on 20<sup>th</sup> September, 2024.

- 6. We did not find any defaced or mutilated Ballot Papers.
- The remote e-voting prior to AGM period remained open from Tuesday, 24<sup>th</sup> September, 2024 (9.00 a.m. IST) to Thursday, 26<sup>th</sup> September, 2024 (5.00 p.m. IST) and NSDL e-Voting System, was disabled thereafter.
- 8. We have also received a complete record of votes cast through electronic mode, upto 5:00 p.m. on 26<sup>th</sup> September,2024 from NSDL, the agency appointed for providing and supervising electronic platform. The votes cast were unblocked on 27<sup>th</sup> September, 2024 at 11:35 A.M (IST) in the presence of two witnesses, who are not in the employment of the Company.
- 9. The e-voting data was scrutinized by us for verification of votes cast in favour and against the Resolutions, as set in the Notice of the AGM.

A summary of the combined voting results of the votes cast through Ballot Papers received and Remote evoting is given as "Annexure A".

We have handed over the Ballot Papers and other related papers/ registers and records for the safe custody to the Chairperson who has been authorized by the Board to supervise the Ballot process.
