With reference to above subject, please find enclosed herewith disclosure in the prescribed format as required under Regulation 10(6) of SEBI (Substantial Acquisition of Shares and Takeover) Regulation, 2011 for acquisition of 35,48,545 equity shares having face value of Rs. 10/- per share by transmission of shares.

This is to inform you that 35,48,545 shares (7.45%) has been transmitted in favour of me i.e. Mr. Parag Hemant Jalan from late Kamala Prasad Jalan. Consequently, my shareholding in Indigo Paints Limited is 51,73,545 (10.86%).

Since the aforementioned transmission is amongst Promoter the same falls within exemption under Regulation 10(1)(g) of SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and hence the aggregate shareholdings of the entire promoter & promoters group remain unchanged at 2,56,86,615 equity shares (53.92%).
