Sub: Intimation of order of Liquidation of M/s Nu Tek India Limited and appointment of undersigned as Liquidator.

Dear Sir,

1. This is to bring to your kind knowledge that, the National Company Law Tribunal, New Delhi (hereinafter referred to as "NCLT"), vide its Order dated 22.06.2020, has initiated Liquidation process of M/s Nu Tek India Limited and Mr. Vineet Aggarwal is appointed as the Liquidator. The relevant extract of the order has been reproduced hereunder for your reference:

".... The present application under section 33(2) of the Insolvency & Bankruptcy Code for appropriate direction to be passed for Liquidation of the Corporate Debtor is allowed and Mr. Vineet Aggarwal is appointed as Liquidator."

A copy of this Order has been attached herewith and enclosed as **Enclosure 1**.

2. Further, order of Moratorium under Section 14 Insolvency and Bankruptcy Code, 2016, shall cease to have its effect. The relevant text of said Section 14 is reproduced herein below for your reference:

"Moratorium

14. (1) Subject to provisions of sub-section (2) and (3), on the insolvency commencement date, the Adjudicating Authority shall by order declare moratorium for prohibiting all of the following, namely: -

- a) the institution of suits or continuation of pending suits or proceedings against the corporate debtor including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other authority;*
- b) transferring, encumbering, alienating or disposing of by the corporate debtor any of its assets or any legal right or beneficial interest therein;*
- c) any action to foreclose, recover or enforce any security interest created by the corporate debtor in respect of its property including any action under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (54 of 2002);*
- d) the recovery of any property by an owner or less or where such property is occupied by or in the possession of the corporate debtor.*

(2) The supply of essential goods or services to the corporate debtor as may be specified shall not be terminated or suspended or interrupted during moratorium period.

[(3) The provisions of sub-section (1) shall not apply to –

- a) such transaction as may be notified by the Central Government in consultation with any financial regulator;*
- b) a surety in a contract of guarantee to a corporate debtor.]*

(4) The order of moratorium shall have effect from the date of such order till the completion of the corporate insolvency resolution process.

3. Further, from the aforementioned Order of the NCLT, all the Directors and key managerial persons of the company are suspended and all the powers of Directors, shall cease to have effect and shall be vested to the undersigned.
