Dear Sir/ Ma’am,

We, Jamshyd Naoroji Godrej, Navroze Jamshyd Godrej, Smita Godrej Crishna, Nyrika Holkar and Freyan Crishna Bieri (collectively “**Acquirers**”), are submitting a report under Regulation 10(7) of the SEBI SAST Regulation in respect of the of the acquisition by us of Equity Shares of Godrej Agrovvet Limited (“**GAVL**”) amounting to 2.16% of the paid-up Equity Share capital of GAVL in aggregate from M/s. RKN Enterprises (“**Transferor**”), a Partnership Firm (the “**Acquisition**”).

The Acquirers and the Transferor have been classified as members of the Promoter Group of GAVL for a continuous period of not less than 3 (three) years prior to the Acquisitions in terms of Regulation 10(1)(a)(ii) of the SEBI SAST Regulations.

The said disclosure has been set out in the **Schedule** below. The intimation under Regulation 10(5) of the SEBI SAST Regulations was filed with the stock exchanges on July 4, 2024 and Report under Regulation 10(6) of the SEBI SAST Regulations was filed with the stock exchanges on July 13, 2024.




