Axis Mutual Fund ("Axis MF") is a mutual fund constituted in India and registered with the Securities and Exchange Board of India ("SEBI") under SEBI (Mutual Funds) Regulations, 1996 vide registration no. MF/061/09/02.

Axis Focused Fund has disposed 0.10% equity shares of Torrent Power Ltd (Target Company) on October 17, 2024 thereby reducing the holding to 5.16% of equity share capital.
