I hereby intimate your good office that Corporate Insolvency Resolution Process (CIRP) has been initiated in respect 'SURANA CORPORATION LIMITED" under the provisions of Insolvency and Bankruptcy Code, 2016 ("Code") by an order of National Company Law Tribunal ("NCLT") with effect from 5th October, 2018. (Order received on 9th October, 2018).

As per section 17 of the Code, the powers of the Board of Directors of "SURANA CORPORATION LIMITED" stands suspended and such powers shall be vested with me (C RAMASUBRAMANIAM) having IP Registration No. IBBI/IPA-002/IP-N00052/2016-17/10096 appointed as the Interim Resolution Professional.

It may further be noted that in consonance with the stipulations contained in Section 14 of the Code, a moratorium has been declared vide the aforesaid order passed by NCLT, whereby, inter alia, the following shall be prohibited:-

- (a) The institution of suits or continuation of pending suits or proceedings against "SURANA CORPORATION LIMITED" including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other authority;
- (b) Transferring, encumbering, alienating or disposing of by "SURANA CORPORATION LIMITED" any of its assets or any legal right or beneficial interest therein;
- (c) Any action to foreclose, recover or enforce any security interest created by "SURANA CORPORATION LIMITED" in respect of its property including any action under the

- (d) Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002;
- (e) The recovery of any property by an owner or Lessor where such property is occupied by or in the possession of "SURANA CORPORATION LIMITED".
