Please note that the Fund Raising Committee ("FRC") at its meeting held today, i.e., 9^{th} September, 2024 approved allotment of 34,782,608 (Three crore forty seven lakh eighty two thousand six hundred and eight only) Equity Shares to eligible qualified institutional buyers at the issue price of ₹ 690 (Rupees six hundred ninety only) per Equity Share, i.e., including a premium of ₹ 680 (Rupees six hundred eighty only) per Equity Share (which includes a discount of ₹ 9.01 (Rupees nine and one paise) to the floor price (i.e.1.29% on the floor price),, aggregating to ₹ 2,400 crores (Rupee two thousand four hundred crores only), pursuant to the qualified institutions placement of Equity Shares.
