Police on Tuesday opposed the bail application of one of the alleged shooters involved in the firing on actor Salman Khan's residence, claiming that he and his accomplice intended to kill the Bollywood actor.

If accused Vicky Gupta was released on bail, he might inform gangster Lawrence Bishnoi, the alleged mastermind of the shooting, about the investigation so far and

crucial evidence could be destroyed, police said.

Gupta was in touch with gangster Lawrence Bishnoi and his brother Anmol before the attack. The prosecution said Gupta was part of the conspiracy to attack the actor's house.

Gupta has moved a bail plea before the special court claiming "he was actually influenced by the character of Lawrence Bishnoi from the electronic, print and social media, and was magnetically attached to the principles fol-



lowed by Lawrence Bishnoi, as Mr Lawrence Bishnoi was an ardent follower of [the freedom fighter] Bhagat Vicky Gupta was in touch with gangster Lawrence Bishnoi and his **brother Anmol** before the attack

He claimed that Bisnoi had been dragged in the case unnecessarily. "It is apparent on the face of record, that the applicant did not received any call from Lawrence Bishnoi nor any middle-man had instigated the applicant to talk with Lawrence Bishnoi, as he is wrongly inducted in the present case, and did not have

any role to play in the present

The prosecution, however, said that Gupta was involved in the crime along with the other arrested and absconding accused. The prosecution further highlighted that Gupta purchased the motorcycle used in the crime at the behest of absconding accused Lawrence and Anmol

The prosecution said that a day before the attack, Gupta had spoken to a few witnesses and shared his plans. Thus, the prosecution said, he was very much aware about everything and participated

Actor's neighbour files case against his Galaxy tenants

Police in Bandra recently filed an FIR against the MD of Legend Leasing and Finance and her husband for committing criminal breach of trust

and causing property damage. In his complaint to the police, Pradip Almadi, 69, said Divya Kushwaha and Jayanta Roy had rented his flat in Galaxy Apartment complex in Bandra (West). Before vacating, Kushwaha and her husband allegedly removed equipment from the flat and damaged items in it.

Actor Salman Khan also lives in the same building.

In 2019, Almadi signed a agreement with Legend Leasing and Finance. The agreement, covering the period from January 2019 to 2022, allowed January Kushwaha and Roy to live in

Until September 2020, the couple were paying Rs2.25 lakh per month as rent. However, they later failed to

make rent payments. As a result, Almadi requested that they vacate the flat and settle the outstanding rent.

Kushwaha assured Almadi that the rent would be paid refused Consequently, Almadi approached the Rent Control Authority. The authority directed Kushwaha to pay the rent and vacate the flat. Kushwaha challenged the authority's decision in the Bombay High Court. The case eventually reached the Court, which Supreme ordered Kushwaha to vacate the flat by July 31, 2024.

Additionally, the court mandated that the remaining rent amount of Rs75.26 lakh be paid to Almadi within eight weeks. Kushwaha handed over the flat to Almadi on July 10, 2024, but did not pay the outstanding

Upon regaining possession of the flat, Almadi discovered that several items were missing. There was also extensive damage to the flat.

Father moves HC, seeks to be heard

The father of a woman, who died in 2021 after falling from her Pune residence's balcony, has approached the Bombay High Court claiming that he should be heard before any order is passed in the PIL by BJP leader Chitra Wagh in which it is alleged that minister Sanjay Rathod was linked to her death.

In February 2021, several photographs of a tribal woman with Rathod and 12 audio clips went viral. The woman later died by suicide. At the time, the MVA was in power. Rathod, who was an MLA from Digras constituency, had to resign then. Wagh then approached the HC seeking registration of an FIR. She had sought a probe by a special investigation team or transfer of the case to CBI.

The FSL stated that the voice in the clip was "similar" to that of Rathod, but was not "identical". Hence, he was given a clean chit.

As new PG students gathered for their orientation programme at the Tata Institute of Social Sciences (TISS), Mumbai, on Monday, they were allegedly hit with an unexpected announcement: hostel allotments would only be provided after they make payment of Rs38,000 (Rs18,000 for accommodation and Rs20,000 as dining hall charges).

Earlier, the institute allowed the students to pay the charges in two instalments. Sources said that from this year TISS will begin the accommodation process after a full and final payment. This has led to frustration among students, many of whom travelled to the campus without prior hostel allotment. Earlier, students were allotted hostels with the instalment option before they arrived.

As per a varsity payment document, "If admitted to hostel, charges of Rs18,000 need to be paid in two equal

NCLT levies ₹60,000 fine on Bombay **Local Pictures**

The National Company Law Tribunal (NCLT) has imposed a compounding fee of Rs30,000 each on Sonya Khan and Feroz Abbas Khan, directors of Bombay Local Pictures Private Limited, after the company failed to present its financial statements at the annual general meetings (AGMs) for the financial years 2010-11, 2011-12 and 2012-13.

The NCLT stated that the total fee of Rs60,000 would serve as a sufficient deterrent to prevent the repetition of such defaults in the future.

The compounding application was filed by the directors acknowledging that they had not presented the statements to the company's members during the AGMs.

The application said that the registrar of companies had not issued any showcause notices to the company or its directors for non-compliance with Section 210 of the Companies Act, 1956. However, recognising the oversight and in a bid to uphold corporate governance, the board decided to pursue the compounding of the offence.

The directors explained that the delay in holding the AGMs within the required time frame, and the subsequent violations of Section 210(1), were accidental and inadvertent, asserting that neither the company nor its directors had any malicious or fraudulent intent.
