Sitharaman: Govt needs money to meet challenges, fund R&D

PTI ■ BHOPAL
Union Finance Minister Nirmala Sitharaman on Tuesday justified the present taxation regime, saying that the country needs resources to meet the challenges facing the nation and also to fund research and development activities. Sitharaman was addressing the 11th convocation of Indian Institute of Science Education and Research (IISER) in Bhopal. While appealing to the scientist community to do more research on the storage of renewable energy, Sitharaman said the world has promised a lot of money towards transitioning from fossil fuel to renewable energy but that money is yet to come. "But India didn't wait. The promises given in Paris (Paris



Agreement) were fulfilled with our own money. There are times when being the finance minister, it doesn't give me motivation when I have to answer people about why our taxes are like this? Why can't we even be lower than this? I wish I can bring it down to almost nil. But India's challenges are severe and challenges will have to be overcome," the finance minister said. She said the government has heavily invested in scientific research. "I seek a very learned crowd before me graduates, PhD holders, to understand India's challenges. I have taken the example of renewable energy, global energy as one of those sustainable sources of energy for a growing country like India," she said.

While urging scientists to come up with innovations, she said that India is moving from fossil fuel to renewable energy at its own strength as the country cannot afford to wait for money from somewhere else. Sitharaman also urged scientists to develop batteries for the storage of the renewable energy as transition from fossil fuel to renewable energy has to be sustainable. "The government is just not talking. It is putting money in R&D (research and development).. Money that is earned out of taxation. That's my job so I will tell you that. My job is to generate revenue but not troubling people, I will assure that. But, even with that money comes because we also need to fund research," Sitharaman said while seeking a reply from the gathering that should there be more money for research? Madhya Pradesh Chief Minister Mohan Yadav, Bhopal's Lok Sabha MP Alok Sharma and other dignitaries were present during the convocation.



Sensex plunges to 693 on closing, market in the red

Equity benchmark BSE Sensex tumbled nearly 700 points to sink below the 79,000 level on Tuesday, extending its losses for the second straight day due to selling pressure in HDFC Bank, SBI and ITC amid fresh foreign capital outflows. Besides, deep losses in commodity, banking and financial stocks and concerns over stretched valuation contributed to the steep market decline, analysts said.

The 30-share BSE Sensex tumbled 692.89 points or 0.87 per cent to settle at 78,956.03. During the day, it tanked 759.54 points or 0.95 per cent to 78,889.38. The NSE Nifty slumped 208 points or 0.85 per cent to 24,139. A total of 2,676 stocks declined while 1,266 advanced and 84 remained unchanged on the BSE. "The domestic market plunged into red terrain in the latter half, amidst mixed global sentiments. Recent IIP data indicates a lacklustre growth in the major manufacturing sector. Persistent selling by FIIs and elevated valuations are further contributing to the decline. All sectors, especially banking, metal were in red, while HDFC Bank declined due to lower-than-expected passive fund inflows in the recent MSCI index rejig," said Vinod Nair, Head of Research,

Geojit Financial Services. From the 30 Sensex firms, HDFC Bank declined over 3 per cent. Tata Steel, Bajaj Finance, State Bank of India, Tata Motors, Power Grid and JSW Steel were the other laggards. In contrast, Titan, HCL Tech, Nestle, Sun Pharma, Reliance and Mahindra & Mahindra were the gainers. Seven firms, including Vodafone Idea and Oil India, would be included in the MSCI India Index effective August 30, 2024, as per the latest index review by MSCI. Dixon Technologies (India), Oil India, Oracle Financial Services Software, Prestige Estates Projects, Rail Vikas Nigam, Vodafone Idea and Zydus Lifesciences are the additions to the MSCI India Index, according to an announcement by index compiler MSCI. The changes in constituents for the MSCI Global Standard Indexes will take place as of the close of August 30, 2024, as per the announcement. Bandhan Bank would move out from the MSCI India Index, it announced. Shares of Rail Vikas Nigam jumped 4.61 per cent, Dixon Technologies climbed 3.29 per cent, Oil India went up by 3.21 per cent, Oracle Financial Services Software (1.95 per cent) and Prestige Estates (1.46 per cent) on the BSE. However, Vodafone Idea and Zydus Lifesciences were trading lower. MSCI is a leading provider of critical decision support tools and services for the global investment community. In the MSCI Global Smallcap Indices list, 27 firms will be included in the MSCI India Index. The additions include Bajaj Hindusthan Sugar, Bandhan Bank, Gulf Oil Lubricants India, Inox Wind Energy and TVS Supply Chain Solutions.
