The Company has paid ₹ 40,20,000/- (Rupees Forty Lakh Twenty Thousand Only) to SEBI towards settlement amount under SEBI (Settlement Proceedings) Regulations, 2018.

There is no material impact on financial, operations or other activities of the Company pursuant to the above-mentioned order.
