1. Brief details of litigation

1.1. Name(s) of the opposing party

The petition has been filed by its shareholders namely (a) Mr. Sudip B Patel, (b) Mr. Nilay S Patel and (c) Mrs. Rachana N Patel. Along with the Company, its Chairman and MD, Mr. Rasesh Patel and Director Mr. Alpesh B Patel is also made party to this petition.

1.2. The court/ tribunal/agency where litigation is filed

The Petition has been filed before Ahmedabad Bench of the National Company Law Tribunal – NCLT.

1.3. Brief details of dispute/litigation

The Petitioner has filed petition under the provisions of Section 245 of the Companies Act, 2013 for alleged Oppressions and mismanagement. They have challenged the Appointment of Mr. Rasesh Patel as Chairman and Managing Director of the Company. They have also challenged the validity of the notice for 43rd Annual General Meeting and financial statements.

2. Expected financial implications, if any, due to compensation, penalty etc.;

The Company do not expect any financial implications due to this petition,
