Dear Sir,

This is further to our earlier communication dated March 29, 2024, regarding the receipt of show cause notices aggregating to Rs.4.55 crores for FY 2019-20, 2021-22 and 2022-23 by its subsidiary i.e. USC Hologram Private Limited from Goods and Service Tax Authority, Hyderabad, Telangana.

We wish to inform that Asst. Commissioner (ST), Basheerbagh – I Circle, Abids Division, Hyderabad has passed the following orders dated 6th July, 2024 (received on 8th July, 2024).

Pursuant to the order passed Claims of the GST authorities aggregating to Rs.59.64 lacs raised vide show cause notices pertaining to Financial year 2019-20, 2021-22 & 2022-23 reported in our earlier communication dated 29th March, 2024, as aforesaid, have been dropped:

- Variation in quantity supplied (Number of Holograms/Heals). [FY 2019-20, 2021-22 & 2022-23]
- Excess claim of ITC (P&L vs. GSTR 9 [FY 2019-20 & 2021-22]

We wish to inform further that the department had earlier issued a show cause notice for Rs.3.95 cores for FY 2019-20, 2021-22 and 2022-23 under Rule – 37 of the GST Rules, 2017 for ITC reversal on non-payment to suppliers within 180 days, which too was reported in the previous communication dated: 29/03/2024. Since the payment had already been made by the Company to the suppliers, the department has thus, confirmed the demand for Rs.2.02 crores towards payment of interest on delayed payment as per rule 37 of the cited GST Rules.

Further, USC Holograms Private Limited has also received fresh show cause notices for the financial year 2018-19 & 2020-21 from Goods and Service Tax Authority, Hyderabad, Telangana.
