Summary of Proceeding of 39th Annual General Meeting of Competent Automobiles Co. Ltd.

The 39th Annual General Meeting (AGM) of members of the Company was held on September 28, 2024 at 11:00 a.m. through Video Conferencing/Other Audio Visual Means (VC/OAVM). Mr. Raj Chopra, Chairman & Managing Director took the chair & welcomed the members. Quorum being present, he started the formal proceedings.

He introduced the members as panelist viz. Mrs. Kavita Ahuja, Whole-Time Director, Mr. Deepak Mehta, CFO, Mr. Ravi Arora, Company Secretary, Mr. Anup Mehta, Auditors, Mr. Kamal K Kumar, CEO and Mr. Amit Kumar Gupta, COO. Mr. K. K. Mehta and Mr. Rohit Gogia could not attend the meeting because of their pre occupations. The Chairperson further confirmed the presence of Statutory Auditors at the meeting. Also, Mr. R C Murada has resigned as Independent Director of the Company w.e.f. August 28, 2024, he was also Chairman of the Audit Committee and Stakeholders Relationship Committee. New Directors are to inducted to Board subject to the shareholders in this AGM, thereafter, Board Committee will be reconstituted.
