## 1. Resignation of Statutory Auditor

The said appointment is pursuant to applicable provisions of the Companies Act 2013 and the SEBI Listing Regulations, 2015. The existing/outgoing Auditor have not raised any concern or issue and there is no reason other than as mentioned in their letter.
