Dear Sir / Madam,

In our earlier intimation dated December 26, 2023, the Company had informed that Zydus Healthcare Limited, a wholly owned subsidiary ("ZHL") had received an intimation under section 143(1) of the Income Tax Act, 1961 ("IT Act"), determining demand of Rs. 284.58 crores, while processing the Return of Income.

Against the said intimation, ZHL had filed Rectification Application under section 154 of the IT Act, before the CPC.

In response to the same, ZHL has received a Rectification Order under section 154 of the IT Act dropping the demand of Rs. 284.58 crores and determined revised demand of Rs. 0.011 crores. The details as required under regulation 30 of Listing Regulations read with SEBI Circular are as below:

The revised demand of Rs. 0.011 crores is determined, since the CPC has given short credit of TDS. ZHL is going to file one more Rectification Application under section 154 of the IT Act, before the Jurisdictional Assessing Officer against the same. Once the rectification order is passed by the		





		Jurisdictional Assessing Officer, this demand of Rs. 0.011 crores will be deleted.
