These equity shares shall rank *pari-passu* with the existing equity shares of the Bank in all respects.

Post allotment, the issued and paid-up equity share capital of the Bank stands increased from  $\ 74,77,99,60,390/\$  comprising of  $\ 7,47,79,96,039$  equity shares of  $\ 10/\$  each fully paid-up to  $\ 74,78,81,83,800/\$  comprising of  $\ 7,47,88,18,380$  equity shares of  $\ 10/\$  each fully paid-up.
