Pursuant to Regulation 30 and Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 we hereby inform that the Company has received Orders on 31st August 2024 from:

- 1. The Office of the Joint Commissioner of State Tax, Gandhi Maidan, Patna-800001 levying a penalty of ₹ 20,000/- under Section 73(9) of the BGST Act 2017 for the period April 2019 to March 2020.
- 2. The Office of Assistant Commissioner, Central Goods and Services Tax, Division-I, Pune II Commissionerate, Shivaji Nagar, Pune, Maharashtra, raising a total GST demand of ₹ 9,38,601/and levying penalty of ₹ 99,172/- under Section 73(9) and 73(10) of the CGST Act, 2017 and MGST Act, 2017 and Section 20 of the IGST Act, 2017 for the period April 2019 to March 2020.

The Orders are currently appealable & the Company will make an assessment to exercise the right to appeal or may evaluate other legal options against the said Orders.

The details of the said Orders as required under Clause 20 of Para A of Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular dated 13th July, 2023 are enclosed herewith as an Annexure 1.
