We hereby to inform you that, due to adverse market conditions in the textile industry, which have significantly impacted demand, our company has decided to take measures to optimize the operations aiming at minimizing fixed cost and improving efficiency.

In alignment with the industry trends and our strategic goals, we have decided to temporarily halt the spinning and weaving operations at our Naidupet unit, Andhra Pradesh. This unit has the capacity to support an annual turnover of INR 160 crore. However, presently due to lower demand, we have been unable to achieve full turnover in this unit.

The Company will closely monitor the situation and will commence Spinning and Weaving operations in the unit at the earliest possible.

The garments operations will continue to operate in Naidupet unit.

We believe that this strategic move will better position us to navigate the current market conditions and emerge stronger once the demand in the textile industry stabilizes.
