मई तक पुलिस हिरासत में भेज दिया। कुमार के वकील ने हिरासत में लेकर उनके मुवक्किल से पूछताछ करने की दिल्ली पुलिस की याचिका का विरोध करते हुए दावा किया कि उसके पास कोई सबूत नहीं है। सोमवार को, कुमार की जमानत याचिका एक सत्र अदालत ने यह कहते हुए खारिज कर दी थी कि प्रतीत होता है कि प्राथमिकी दर्ज कराने का मालीवाल का कोई 'पूर्व-नियोजित' इरादा नहीं था और उनके द्वारा लगाए गए आरोपों को खारिज नहीं किया जा सकता। कुमार के खिलाफ 16 मई को भारतीय दंड संहिता के विभिन्न प्रावधानों के तहत प्राथमिकी दर्ज की गई थी।




