Summary of the Proceedings of the 32nd Annual General Meeting of the Company

The 32nd Annual General Meeting (AGM) of the Members of the Company was held on Friday, 30th August 2024 at 03:00 p.m. through Video Conferencing/ Other Audio Visual Means (VC/OAVM) platform provided by CDSL.

Mrs.Geetika Khandelwal, Chairperson took the Chair and presided over the meeting.

Mrs.Geetika Khandelwal welcomed the members and informed that the meeting is being held through electronic mode in conformity with the regulatory provisions and Circulars issued by the Ministry of Corporate Affairs, Government of India and Securities Exchange Board of India (SEBI).

After the receipt of confirmation of requisite quorum being present, the Chairperson called the meeting to order. She informed the Members that the Company has taken all feasible efforts to enable members to participate through video conference and vote at the AGM.

The Directors who were present at the meeting were introduced by the Chairperson of the Meeting. The Chairpersons of the Committees were present at the Meeting. She also informed about attendance of representatives of Auditors including the Statutory Auditor and the Secretarial Auditor.

The Chairperson also informed that Ms.Suman Bajoria, Practicing Company Secretary is the Scrutinizer to scrutinize the remote e-voting and e-voting process at the AGM in a fair and transparent manner.

The Chairperson informed the Members that the registers and documents, as statutorily required, were made available electronically for inspection by the members during the AGM.

Ms.Prakriti Sarvouy, Company Secretary, informed the members that the Company provided remote e-voting facility through the platform of Central Depository Services (India) Limited from 10.00 A.M. on Tuesday, 27 August 2024 and ends at 5.00 P.M. (IST) on Thursday, 29 August 2024. She further informed that the e-voting facility was also made available during the AGM for the benefit of the members who were present during the meeting and had not casted their votes earlier through remote e-voting.

Thereafter, the Annual Report and the Notice convening the 32nd AGM of the Company was taken as read, with the consent of the Members present.

The Chairperson then gave opportunity to the Members who had registered themselves as Speakers to ask questions or seek clarifications on the Agenda items. No queries were raised / clarifications sought by the Members.
