Sub: Intimation of expected delay in Submission of Annual Financial Results for the year ended March 31, 2024, and quarterly results for the quarter ended June 30, 2024 and half year ended September 30, 2024 and consequent request for extension of timeline to hold Board Meeting beyond October 14, 2024

Dear Sir / Madam,

As per the provisions of Regulations 33 and 52 of the SEBI LODR Regulation, 2015, all listed entities are required to submit their annual financial results to the stock exchange(s) within 60 days from the end of the financial year in the PDF and XBRL format. Quarterly results to be submitted with 45 Days from the quarter ending date.

With reference to the above, we would like to bring to your kind attention the fact that we were facing some unprecedented technical difficulties with our financial accounting system. As a result of the same, our staff and statutory auditors were incapacitated and unable to generate the requisite information for finalization of accounts within the stipulated timelines. We resolved the same shortly and now our Audit is under process. We expect to complete the audit soon and finalize our accounts.

While our audit is still under process, it is incumbent on us to intimate the delay in finalization of said accounts for FY 2023-24 and declare the financial results with the stipulated time of 60 days from the end of financial year and quarterly results for the quarter ended on June 30, 2024 and half year ended September 30, 2024.

In furtherance of the above, we have applied for extension of holding Annual General Meeting for F.Y. 2023-24 to Registrar of Companies, Maharashtra and same has been approved by them and granted extension for the period of the 3 months.
