Consequently, the Company has carried out valuation of this land from an independent certified valuer & shortfall on realisation, if any, will be accounted for in the year of final recovery/ settlement.
  - b) In view of uncertainty of ultimate collection of further interest, the company has not accrued interest income on the said inter-corporate loan (net of provision) for the quarter ended June 30, 2024 amounting to Rs. 229.29 Lakhs. During the year, no major development has occurred and the company has continued the same judgement in relation to provision of Rs. 300 Lakhs.

Company has filed a Miscellaneous Application (MA) to the ITAT & MA has been heard but the final decision from ITAT is pending. As per the ITAT order, Tax liability works out to be Rs. 1529.42 Lakhs including interest.
