Investment in a Special Purpose Vehicle (SPV) for supply of 18 MWp Ground Mounted Solar Power:

Aligning with the Company objective to be a 100% Renewable energy consumer by the year 2030, the Board of Directors of the Company, has, at its meeting held today, approved after due evaluation of various proposals presented, an equity investment not exceeding Rs. 4.00 Crore for acquiring/maintaining upto ~26.33% equity share capital of Bhargavi Renewable Private Limited ("BRPL"), a Special Purpose Vehicle, for setting up of 18 MWp Ground Mounted Solar Power Plant for supply of power to Vapi facilities which would make the Company's Vapi facilities upto 60% RE by the financial year 2025 with a reduction in the cost of power. The Company proposes to enter in Power Purchase Agreement (with Take or Pay arrangement) with BRPL for supply of renewable power for a period of 25 years with an interest free security deposit upto Rs. 2.15 Crore.
