 exceeding Rs. 25 Crores, as on the last date of the previous financial year.
 Provided that where the provisions of the regulations specified in this regulations becomes
 applicable to a listed entity shall comply with the requirements those regulations within six
 months from the date on which the provisions became applicable to the listed entity.
- 2. Companies whose equity capital is listed exclusively on the SME &SME- ITP Platforms.

Please note that the paid up equity share capital and net worth as the audited balance sheet as at 31st March 2024 of our company were Rs. 7, 92,47,600 and Rs. 21.33 Crs respectively. The net worth is way below the prescribed limit, for applicability of corporate governance clause to our company, as per Regulation 15(2) (a) of SEBI (LODR) 2015.

Hence our company would avail exemption under various regulations, relating to corporate governance, prescribed under Regulation 15(2) of SEBI (LODR) 2015for the financial year 2024-25.
