होईंगच्या प्रश्न ऐसपीट

कल्याण, (वा.) कल्याण-डोंडिवली महामार्ग पालिकेच्या हलगर्जीपणामुळे कल्याण पश्चिमेकाला सहजानंद चौकात लावण्यात आलेले एक मोठे होईंग अचानक कोसळून तीन जण जखमी झाले तर अनेक गाड्यांचे नुकसान झाले आहे. शुक्रवारी सकाळी दहा वाजण्याच्या सुमारास ही घटना घडली. कल्याण पश्चिमेकाला सहजानंद चौका परिसरात रस्त्याच्या चांदी बाजूला मोठ्या मोठ्या उभारण्यात आले आहेत. या होईंगच्या मुल्यमात्र प्रत्येक वाटावर उभिरित करूनही महापालिका प्रशासन त्याकडे कानाडोळा करत असतानाच शुक्रवारी ही घटना घडली. सकाळी दहा वाजण्याच्या सुमारास सहजानंद चौकात काडी हायस्पीड शेंडारीने हे मोठे मोठे होईंग अचानक खाली कोसळले. ज्यामध्ये तीन नागरिक जखमी झाले असून, अनेक दुचाकी, काही थिए आणि एक कारचे नुकसान झाले आहे. शुक्रवारी सकाळी होत असलेल्या जोरदार पंजमव्यूमुळे कल्याण पश्चिमेकाला सहजानंद चौक येथे लावण्यात आलेल्या होईंगच्या पुढील बाजूस लावलेले बॅनर्सचे पत्रे पडल्याने खाली उण्या असलेल्या गाडीचे नुकसान झाले. ही घटना घडताना महापालिका आयुक्त डॉ. इंदु राणे जखड, अतिरिक्त आयुक्त रमेश पाणकडकर, माहामता विभागाचे उपअ्युक्त ज्येष्ठ मिसाल यांनी घटनास्थळी भेट देवून परिस्थितीचा आढावा घेतला.
