Sub: - Allotment of 1,43,00,000 (One Crore Forty-Three Lakhs) Convertible Equity Share Warrants to promoters and certain non-promoters of Ambo Agitec Limited ("the Company")

Pursuant to the approval of the Board of Directors of Ambo Agritec Limited (the "Company") at its meeting held on May 09, 2024 and the approval of the members of the Company at their Extra Ordinary General Meeting held on June 03, 2024 and in accordance with the In-principle approval granted by BSE Ltd ("BSE") vide its letter dated June 10, 2024, and upon receipt of an amount aggregating to ₹10,72,50,000 (Rupees Ten Crores Seventy Two Lakhs Fifty Thousand only) at the rate of ₹7.5 per warrant (being 25% of the issue price per warrant) as the warrant subscription price, the Board of Directors of the Company has considered and approved the allotment of 1,43,00,000 (One Crore Forty Three Lakhs) warrants on a preferential basis issued at a price of ₹30 each (Rupees Thirty only) warrant [including the warrant subscription price (₹7.5 per warrant) and the warrant exercise price (₹22.5 per warrant)], aggregating to ₹42,90,00,000 (Rupees Forty Two Crores Ninety Lakhs only), to promoters and certain non-promoter individuals, as per the list enclosed marked as **ANNEXURE I** ("Allottees").

Each of the Warrants, so allotted, is convertible into one fully paid-up equity share of face value of ₹10/-(Rupees Ten only) of the Company in accordance with the provisions of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI ICDR Regulations") upon payment of the balance consideration of ₹22.5/- per warrant (being 75% of the issue price per warrant), in one or more tranches, from the Allottees and allotment of equity shares shall be made pursuant to the exercise of the conversion option against each such warrant.

The meeting of the Board of Directors commenced at 7.00 P.M. and concluded at 8.10 P.M.
